Research, Teaching and Service Interests

My research interests in archaeology have been focused upon reconstructing political dynamics of ancient complex societies in Latin America and the American Southwest. I have worked on this topic – and within the field of archaeology – since 2011, having approached the discipline from a background in the environmental sciences. In this time I have gained a variety of field experience, working in Romania, New Mexico, Belize, Peru, and Chile. My Master's degree (2015) and dissertation work (in progress) have been particularly focused upon provincial communities of the Inka Empire in western South America. Since 2013 I have centered my fieldwork on this topic at the site of Turi in the Upper Loa region of Chile's Atacama Desert, where I study the relationship between settlement organization and the display of imperial monumental architecture to provincial communities.

My work in Latin America is also complemented by interests in the American Southwest. From 2014 to 2018 I have assisted in several academic research projects directed by W.H. Wills pertaining to Chaco Canyon, and have developed a resume in CRM project management within the state of New Mexico.

My teaching and service interests include undergraduate education, site preservation, the promotion of Latin American studies in anthropology, and the communication of archaeological research to the public in an accessible manner. These goals are realized through field instruction as a teaching assistant or crew manager, and synthetic overviews of my own research in Latin America provided as public talks and recorded interviews made publicly available online.
