# **SCHOLARSHIP, TEACHING AND SERVICE INTERESTS**

**SCHOLARSHIP.** My research addresses health disparities in substance use disorders in rural and underserved communities through development and testing of innovative implementation approaches. The ultimate goal of my implementation science research agenda is to support uptake and expansion of best practices in treatment, recovery, harm reduction and prevention in the area of substance use and co-occuring disorders. My early research informed my current research agenda starting with a focus on understanding and improving health disparities in New Mexico. This includes an ethnographic study of teen pregnancy and parenting conducted over two years in an urban high school in Albuquerque involving Anglo, Hispanic and American Indian youth to understand youth cultures and their impact on teen pregnancy and parenting (Salvador/aka Griffin, 2001). My experience working with youth in the public school system led to my subsequent co-development of a community-based participatory research study examining use of, and attitudes towards, school-based health services. This was conducted in partnership with school-based health center staff from the Native American Community Academy (Salvador, Goodkind, Feldstein Ewing, 2015). Additionally, early research included examination of the impact of a culturally appropriate diabetes lifestyle intervention with New Mexico pueblo communities, funded by the National Institute of Diabetes and Digestive and Kidney Diseases, with subsequent completion of two first-authored publications (Salvador/aka Griffin, Gilliland, Perez, Helitzer, & Carter, 1999; Salvador/aka Griffin, Gilliland, Perez, Upson & Carter, 2000). This prior work with Native American communities and healthcare providers informed my subsequent research study aimed at understanding barriers and facilitators to implementation of evidence-based practices in the area substance use (NIDA funded, 2011). This study included six rural New Mexico communities including one Native American community, with high substance use disorder needs (Salvador, Altschul, Rosas, Goldman, & Feldstein Ewing, 2018). Following these studies, my current implementation sciences research focuses on understanding the impact of innovative implementation models, including webbased approaches, on the expansion of evidence-based practices in substance use disorder treatment. Specifically, I am currently Principal Investigator on a 5-year study (2017-2022, Agency for Healthcare Research and Quality) examining the impact of the Extensions for Community Healthcare Outcomes (ECHO) model on expansion of treatment of opioid use disorders using buprenorphine in rural primary care (Salvador et al, 2019). In addition to these primary research efforts, and in keeping with my personal and professional goal to improve and expand evidence-based services in New Mexico, I have collaborated extensively with the state of New Mexico Department of Health and Human Services since 2008; in particular, with the New Mexico Behavioral Health Services Division and the Children, Youth & Families Department. Along with several prior collaborative services research grants, I am currently Principal Investigator on two of New Mexico's largest opioid use disorder services research efforts to improve treatment, recovery, harm reduction and prevention services statewide to address opioid use disorder related morbidity and mortality. Combined external grant funding

for these collaborative opioid efforts totals over \$22 million, with additional funding of over \$15 million expected in September 2020.

**TEACHING.** I have an inclusive approach to teaching and education that is focused on enhancing knowledge, skills and capacity of a broad range of learners in four main groups. The first group of learners include academicians such as medical students, residents, fellows, and faculty. For this group, I teach in mainly traditional classroom lecture/discussion formats and one-on-one venues to build knowledge and skills in research and methodology, particularly qualitative methods, implementation science, and substance use disorders. The second group of learners are clinicians practicing statewide and nationally. I support their continuing education in opioid use disorder and associated medication-based treatments. My major contribution in this area is the development of an innovative, 12-session ECHO-based continuing education curriculum to educate providers and other clinic staff in opioid use disorder treatment using medications, psychosocial treatment and recovery supports (see Educational Innovation page). This was developed in collaboration with Dr. Snehal Bhatt with the UNMH Addictions and Substance Abuse Programs (ASAP), and with Dr. Vanessa Jacobsohn. This MAT ECHO is available to New Mexico primary care providers primarily but is also open to other providers/staff nationally with my approval. The MAT ECHO has participation currently from California to Washington DC and many states between. Participation includes both potential and practicing Suboxone prescribers (physicians, nurse practitioners, and physician assistants) as well as therapists, counselors, case managers, community support workers, and administrative staff at clinics statewide in behavioral health and primary care settings. This curriculum has been published in the peer-reviewed journal Substance Abuse (Salvador et al, 2020. https://www.tandfonline.com/doi/full/10.1080/08897077.2020.1806184). The third group I teach is state leadership and policy makers in New Mexico in order to support the implementation of evidence-best practices for substance use disorders in New Mexico. This education includes lectures and presentations to these decision-makers based on study data and is accompanied by written reports and policy briefs. Lastly, I teach youth and family members who are engaged in research projects. This education aims to build their understanding of the research from methodology to outcomes, stimulate discussion of concerns and suggestions for alternative approaches, and determine the best ways to share and disseminate study findings (see development of Zines and games to engage youth and families in my teaching narrative).

**SERVICE:** As Principal Investigator for two of the largest grants in New Mexico addressing Opioid Use Disorder (State Targeted Response grant and for the State Opioid Response grant) one aspect of my role focuses on service to the state of New Mexico, including state leadership, provider agencies and community members. I serve as the lead for all grant aspects including statewide administration, implementation and research. I regularly work with over 60 partners including academic (Department of Family and Community Medicine, UNM Hospitals Addictions and Substance Abuse Programs, and the ECHO institute), community partners including primary

care, behavioral health, law enforcement and recovery agencies and multiple state divisions under the Department of Health and Human Services. In addition, I am a member of the Department of Psychiatry and Behavioral Sciences Scholarship/Research Committee. This committee was developed with the goal of enhancing department-wide research and associated academic contributions. This includes introducing and involving clinicians in research and other scholarly activities. I also have played key roles in planning and development for national conferences. This includes development of the first Global Implementation Conference in 2011 where I served on the initial conference Planning Committee to design all aspects of the event from selection of conference planners, invited keynote speakers, break out groups and similar. This was very successful with the GIC held bi-annually since 2011 in both national and international venues. In addition, I served on the National Association of Rural Mental Health Conference Planning Committee and helped host this event in Albuquerque, New Mexico in 2019.

#### **CONTINUING MEDICAL EDUCATION**

#### OTHER CONTINUING EDUCATION AND COMMUNITY-BASED EDUCATION

In addition to classroom-based teaching and individualized teaching, I also am actively engaged in teaching of community members. The general focus of much of this education pertains to research and evaluation of community-based health education initiatives. Education for community-based clinicians includes developing logic models, short and long term outcomes to help build or modify programs and track data for quality improvement purposes (continuous quality improvement: CQI). I have provided similar education for state-level program coordinators, managers and directors to improve their capacity to select and track key outcomes to inform CQI and inform programmatic funding decisions. For community members (often youth and families) I have created interactive lectures and interactive learning events to help build skills in research (purposes, value, and key concepts) and discussions of data (ownership, co-ownership, collecting and providing research data, and use in CQI and planning purposes). Below are examples of these community-based educational events:
